

2. The sanction will be subjected to the terms and conditions mentioned below:
- a) Business class air fare of serial no. 1 will be borne by the United Nations Headquarters and daily allowances, other expenditure will be borne by the Cabinet Division . Economy class air fare and daily subsistence allowance of serial no. 2, 4 and 6 will be borne by UN Women Bangladesh. As the serial no. 2 and 4 are entitled to business class so the additional expenses for business class air fare and other admissible allowances for them will be borne by the respective ministries.
 - b) Expenditure of Serial no. 3 and 5 will be borne by the respective ministries. Expenditure of Serial no. 7 will borne by DANIDA of Multi-Sectoral Programme on Violence Against Women and expenditure of serial no 8 and 9 will be borne by the Ministry of Women and Children Affairs.
 - c) The period of this programme and the time spent for travel and transit will be treated as on duty;
 - d) They will draw their pays and allowances in local currency. No part of it shall be drawn in foreign currency;
 - e) They will not extend their stay abroad beyond the permitted period;
 - f) Honorable State Minister, Secretary, MOWCA along with serial no 8 and 9 will leave Dhaka for New York on 17 March 2017 and will leave New York for Dhaka on 27 March 2017 or a nearer date. Serial 3, 4, 5, 6 and 7 will leave Dhaka for New York on 11 March 2017 and will leave New York for Dhaka on 25 March 2017 or a nearer date.
